Descripción

The course aims at introducing students to the interdisciplinary study of international relations and focuses on the two major approaches therein: International law and International Relations. This course expects to get students acquainted with the most important tools of these two disciplines and, hence, is conceived as a cross-cutting introduction to the analysis of international law and politics.

The course will fuse a theoretical, conceptual approach and a practical focus on contemporary international issues, adopting a legal and a political angle. Students will get an overview of the international system and will study its main components: the actors, the processes and the structure, as well as a deeper treatment of some issues and cases high in the global agenda. This refers to international humanitarian law, human rights or international conflicts. Besides, the course will pay attention to the analysis of Spanish foreign policy-making system.

Objetivos. Conocimientos y habilidades

As laid out above, the **main objective of the course** is to make students familiar with the main issues in International Relations and International Law, both in theory and practice. The course seeks to provide students with an understanding of the relevance and role that the study of international relations has in today's world. It also aims at providing students awareness of global, important issues.

The course seeks to facilitate students essential **knowledge and abilities** on these two areas and properly skill them. Thus, at the end of the semester students are expected to have acquired expertise in the following items

Knowledge

- [1] Identifying the main tenets of International Law and International Relations, and having a solid background therein
- [2] Analysing the most important elements of the international system: actors, structure, processes and norms
- [3] Understanding the main trends in international legal and political developments in the post Second World War times
- [4] Assessing related aspects: foreign policy-making systems and machineries, international conflicts, global trends, features of the international society

Abilities

- [1] Qualification to summarise, analyse and understand relevant international events and structures, from a legal and political perspective, and with a practical and a conceptual-theoretical focus
- [2] Capacity to discern the roles and functions of states, international organisations and other diplomatic actors, as well as the nature of the relationship among them and the international outcomes
- [3] Faculty to address on their own the main aspects of international relations and law and expand their knowledge and interest in these fields
- [4] Competence to come to conclusions and generalisations about aspects related to the course out of case studies and practical exercises
- [5] Rigour to work on a concrete topic throughout the course, as well as presenting it both orally and in written format

Metodología docente

Course design

The course is intended to combine different approaches and methods to give students the key elements to understand, analyse and scrutinise the tenets of International Law and International Relations. Thus, the course will be laid out as follows

Lectures: during the lectures the main concepts of the course will be presented, discussed and debated. Lectures (14%) will combine a conceptual as well as practical overview on the main subjects under discussion, combining historical accounts with discussion on breaking political events and legal aspects.

Seminars and workshops (5%): a significant amount of the workload will be devoted to students' work at home. This will take the form of written and oral contributions and assignments

Semi-presencial: 81%

Practical cases: case studies on different politically important topics, debate on current events, and so on

Material: students will have at their disposal all types of documents and materials that will either help them throughout the course or serve as the basis of continuous assessments. *Prima facie*, this supporting stuff will be

Power Point presentations: presentations discussed in class will be uploaded onto Campusnet after the classes. Guidance materials: links, websites and other Internet-based materials

Articles, working papers, memos... and other documents for debate and discussion, normally addressed to prepare class activities
